9:14 a.m. **Public Hearing-Amend Speed Limit Ordinance**

Public Works Director Matt Mahoney gave a background on Ordinance 04-2019. On April 9, 2019, the Board of County Commissioners passed Ordinance 01-2019, which set the regulations for speed limits in Franklin County with respect to RCW 46.61.400. The ordinance was codified in the Franklin County Code as Chapter 10.08.

The Public Works Department has drafted an ordinance that will amend the aforementioned section to include the new road to Juniper Dunes Wilderness Area and adjacent Off-Highway Vehicle (OHV) area now known as Juniper Dunes Road per Resolution 2019-219.

State law (RCW 46.61.400) sets Washington's basic speed law and the maximum speed limits for state highways, county roads, and city streets. County roads are set at 50 MPH. The statute also authorizes agencies to raise or lower these maximum speed limits, when supported by an engineering and traffic investigation as defined in RCW 46.61.415.

The Public Works Department has determined, based on an engineering and traffic investigation, that roadway characteristics, alignment, sight distance, and grade warrant the speed to be set per the design at 35 MPH.

In addition, a scrivener's error was discovered and will be corrected for the beginning milepost (MP) for Road 80. The beginning of pavement should read MP 0.52 that also affected the overall length that should read MP 0.49.

9:14 a.m. Commissioner Koch opened the Public Hearing for comments to hear testimony for or against the Amendment to Speed Limit 04-2019 Ordinance. No comment from the public.

Commissioner Didier related complaints he received on Glade Road speed limit postings. In addition, he would like to see other avenues for farmers to expedite crops other than Glade Road and 395.
