BACKGROUND INFORMATION

Connections Consulting MA LLC has a Contract with the Benton-Franklin Counties Juvenile Justice Center via Benton County Resolution 2019 776 and Franklin County Resolution 2019 318.

SUMMARY

Contractor has requested to have the contract reflect recently married name of Maria Knight and reflect the agreed increase rate of \$60.00 per hour. Contract Amendment No. 1 replaces the language of Sections 3.a., "Contract Representatives" and 4.a. "Compensation".

RECOMMENDATION

We recommend that the Board of Commissioners of Benton County and the Board of Commissioners of Franklin County sign the Personal Services Contract Amendment No. 1 between Connections Consulting MA LLC and Benton-Franklin Counties Juvenile Justice Center to update Contractor's name and rate increase.

AMENDMENT NO. 1 TO PERSONAL SERVICES CONTRACT BETWEEN THE JUVENILE JUSTICE CENTER AND CONNECTIONS CONSULTING MA LLC

This Amendment No. 1 to the Personal Services Contract (the "Amendment") is entered into by and between Connections Consulting MA LLC and **BENTON COUNTY** and **FRANKLIN COUNTY**, state of Washington political subdivisions (jointly the "Counties"), for and on behalf of the Benton-Franklin Counties Juvenile Justice Center, a bi-county agency ("Juvenile Justice Center").

- The rate of \$60.00 per hour for each hour of interpreting services provided for an individual and/or family during court proceedings or for Diversion, Becca, Community Supervision, Detention and Parent Pay matters at the Benton-Franklin Counties Juvenile Justice Center or other community-based locations as scheduled by Benton-Franklin Counties Juvenile Justice Center staff.

Except as expressly provided in this Contract Amendment No. 1, all other terms and conditions of the original Contract remain in full force and effect.

This Amendment shall be effective upon execution by the parties.
