BEFORE THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, WASHINGTON

**RE: AUTHORIZING THE FRANKLIN COUNTY CORONERS OFFICE TO ISSUE A PURCHASE ORDER TO LEASE A KONICA-MINOLTA BIZHUB C3050i COPIER SUPPLIED BY ABADAN, THROUGH NASPO VALUE POINT MASTER AGREEMENT #140597, AND WASHINGTON PARTICIPATING ADDENDUM #06619.**

**WHEREAS**, the Franklin County Coroners Office desires to issue a purchase order to lease a Konica-Minolta Bizhub C3050i copier on a 60 month Operating Lease through NASPO Value Point master agreement #140597, and Washington Participating Addendum #06619.

**WHEREAS**, the County is not required to enter into a lease agreement for said lease; and

**WHEREAS**, the cost per copy and supplies excluding paper are regulated by the referenced NASPO Value Point contract; and

**WHEREAS**, pursuant to RCW 36.0 1.010 and RCW 36.32.120 the legislative authority of each county is authorized to enter into contracts on behalf of the county and have the care of county property and management of county funds and business; and

**WHEREAS**, the Board of Franklin County Commissioners constitutes the legislative authority of Franklin County and desires to authorize the purchase order as being in the best interest of Franklin County;

**NOW, THEREFORE, BE IT RESOLVED** the Franklin County Board of Commissioners hereby authorizes the Franklin County Coroner’s Office to issue a purchase order to Lease a Konica-Minolta Bizhub C3050i copier through NASPO Value Point master agreement #140597, and Washington Participating Addendum #06619.
