Summary / Background Information

The 2021 Franklin County Juvenile Operations and Facilities Budget was submitted in the amount of \$6,086,835. Based upon the juvenile population per the Office of Financial Management data tables, Franklin County is responsible for 35.98% or \$2,172,211. Franklin County is responsible for 5% of actual expenditures on the Operations and Facilities Budget. To maintain adequate cash flow, Franklin County is responsible for 5% of their portion (\$846,633) of the grant reimbursement and contract fee for services departments budget which equates to \$42,332.

Fiscal Impact

Starting January 1, 2021, Franklin County is responsible for flat monthly payments in the amount of \$184,545.25.

Recommendation

I recommend that the Board of Commissioners of Benton County sign the Resolution for flat monthly payments by Franklin County.

**IN THE MATTER OF ADOPTING FRANKLIN COUNTY FLAT MONTHLY PAYMENTS FOR
THE 2021 BENTON FRANKLIN JUVENILE JUSTICE CENTER OPERATIONS AND
FACILITIES BUDGET**

WHEREAS, the Boards of Benton and Franklin County Commissioners approved Joint Resolution Benton County 2016-942 and Franklin County 2016-436 a Memorandum of Understanding regarding the allocation of Juvenile Justice Center operations and facilities; and

WHEREAS, The Boards of Benton and Franklin County Commissioners amended and approved Section 1.A of the Memorandum of Understanding regarding the allocation of Juvenile Justice Center operations and facilities via Joint Resolution Benton County 2017-807 and Franklin County 2017-332; and

WHEREAS, Joint Resolution Benton County 2016-942 and Franklin County 2016-436 established an administrative fee of 5% on Franklin County's allocation of the total 2021 Benton and Franklin Juvenile Justice Center budget; and

WHEREAS, the 2021 Benton and Franklin Juvenile Justice Center Operations Budget was submitted to Franklin County in the amount of \$5,863,371. Based upon the ratio of each county's juvenile population averaged over five-year periods per the Office of Financial Management data tables attached, Franklin County is now responsible for \$2,109,641 or 35.98% plus a 5% administrative fee based on actual expenditures; and

WHEREAS, the 2021 Benton and Franklin Juvenile Justice Center Facility Budget was submitted in the amount of \$223,464. Based upon Joint Resolution Benton County 2016-942 and Franklin County 2016-436, Franklin County is now responsible for \$62,570 or 28% plus a 5% administrative fee based on actual expenditures, effective January 1, 2021; and

WHEREAS, the combined total for the 2021 Benton and Franklin Juvenile Justice Center Operations and Facilities Budget is \$6,086,835. Franklin County is responsible for a total of \$2,172,211 plus a 5% administrative fee based on actual expenditures; and

WHEREAS, the 2021 Benton and Franklin Juvenile Justice Center Contract-Fee for Services Budget was submitted in the amount of \$1,292,364. Based upon the ratio of each county's juvenile population averaged over five-year periods per the Office of Financial Management data tables attached, Franklin County is responsible for 35.98% or \$464,993 plus a 5% administrative fee based on actual expenditures effective January 1, 2021; and

WHEREAS, the 2021 Benton and Franklin Juvenile Justice Center Grant-Reimbursement Budget was submitted in the amount of \$1,060,702. Based upon the ratio of each county's juvenile population

averaged over five-year periods per the Office of Financial Management data tables attached, Franklin County is responsible for 35.98% or \$381,641 plus a 5% administrative fee based on actual expenditures effective January 1, 2021; and

WHEREAS, the combined total for the 2021 Benton and Franklin Juvenile Justice Center Contract Fee for Services and Grant -Reimbursement Budget is \$2,353,066. Based upon the ratio of each county's juvenile population averaged over five-year periods per the Office of Financial Management data tables attached, Franklin County is responsible for a 5% administrative fee based on actual expenditures on 35.98% or \$846,633 of the budget; **NOW THEREFORE**,

BE IT RESOLVED, to maintain adequate cash flow in the Juvenile Center Fund, starting January 1ST, 2021 Franklin County will be responsible for a flat monthly payment in the amount of \$184,545.25 plus a 5% administrative fee on actual expenditures for the 2021 Benton and Franklin Juvenile Justice Center Operations and Facilities Budget; and

BE IT FURTHER RESOLVED, Benton County shall invoice Franklin County monthly for the County's total flat monthly payment; and

BE IT FURTHER RESOLVED, Franklin County's payment to the Benton County Treasurer shall be no later than 20 days from the date of each invoice; and

BE IT FURTHER RESOLVED, no later than April 2022, Franklin County will receive a final 2021 invoice itemizing actual yearly expenditures and any adjustments necessary based on actual expenditures for the Juvenile Operations and Facilities budget.
