WHEREAS, in accordance with RCW 41.14.030 Civil Service Commission members shall be appointed by the Board of County Commissioners; and

WHEREAS, resolution 2017-192 appointed Michelle Andres to the Franklin County Civil Service Commission to a partial term ending on February 10, 2021; and

WHEREAS, the application of RCW 41.14.030 requires the terms of Civil Service Commissioners to be staggered in two-year intervals; and

WHEREAS, the current terms of the two other Civil Service Commission members end in 2023, and 2025; and

WHEREAS, Michelle Andres has expressed interest in serving a full six-year term; and

WHEREAS, the Franklin County Board of County Commissioners deems this to be in the best interest of the County.

NOW, THEREFORE IT IS HEREBY RESOLVED the Franklin County Board of County Commissioners appoints Michelle Andres to the Civil Service Commission for a six- year term from February 11, 2021 through February 10, 2027.
