## Summary / Background Information

On March 2, 2021, and March 9, 2021, respectively, by Joint Resolution 2021-039/2021-211, the Boards of Franklin County and Benton County authorized the purchase of two (2) 2021 Ford Escape AWD SUV's for use by Benton Franklin Counties Juvenile Justice Center from Columbia Ford utilizing Washington State Contract No. 05916.

On March 1, 2021 Bud Clary Auto Group dba Bud Clary Ford/Hyundai acquired Columbia Ford. The legal name of the dealership is Clary Longview, LLC and checks will be made to Clary Longview, LLC. The State Contract has been updated to reflect these changes.

Joint Resolution 2021-039/2021-211 needs to be amended to also reflect these changes.
