SUBJECT: Resolution Accepting the Work performed by Construction Ahead, Inc dba Pavement Surface Control (PSC) of Kennewick, Washington for County Road Project (CRP) 620 – Hailey Railroad/Highway Crossing.	
FISCAL IMPACT: PSC was awarded the above-mentioned construction contract for \$52,760; final cost of the contract is \$52,760.00. FHWA Highway – Safety Improvement Program (HSIP) grant funds committed \$82,830 for the construction phase of this project including staff's time. This phase is 100% funded with grant funds. Any non-eligible expenditures were funded through 595.12 – Construction Engineering.	
BACKGROUND: On October 1 st , 2019, the Board of County Commissioners executed a contract for CRP 620 – Hailey Railroad/Highway Crossing with Construction Ahead dba Pavement Surface Control (PSC) for \$52,760 (Resolution 2019-302). The contract was for the installation of solar-powered flashing LED traffic signs with vehicle motion detection, temporary traffic control, and other related work at the Hailey Road and BNSF Railroad crossing located approximately 1.3 miles south of Mesa. On December 9 th , 2020, PSC physically completed the project for the contracted amount. Section 1-05.12 of the Contract Specifications states that once the Contractor has performed all the obligations under the contract a completion date and final acceptance will be established. Franklin County Public Works has received all necessary documentation and releases to close out the contract.
