#### FRANKLIN COUNTY PROCLAMATION

Commissioner Bob Koch read the Proclamation of Older Americans Month

#### WASHINGTON STATE UNIVERSITY EXTENSION 4-H YOUTH UPDATE

WSU Extension 4-H Coordinator Natalie Kinion presented the Board with new information from the past year.

- 95 volunteers completed the New Leader training in 2016
- 373 total 4-H Volunteer Leaders
- 1300 Youth Members
- 42 Youth completed 4-H in their Senior Year
- No longer able to do Family clubs- Must be a Charter club to use 4-H name
- Creating more curriculums for youth in classrooms with non-traditional 4-H project areas, including entomology, bridge building, woodworking, Lego robotics and more.

- STEM program available at Basin City, Robert Frost and Mesa elementary schools.
- Columbia Basin College has been a great partner for Science Camps.

## PERSONAL SERVICES CONTRACT WITH DANETTE LAYNE, LLC. FOR COMPENSATION REVIEW SERVICES AND RELATED BUDGET TRANSFERS

Administrator Keith Johnson and Human Resources Director Carlee Nave presented the Board with Resolution 2017-111 contracting with Danette Layne for compensation review services and related budget transfers. This would allow Ms. Layne to gather salary data, update job descriptions and compile data to present to the Board.

#### COLUMBIA-SNAKE RIVER IRRIGATORS ASSOCIATION PRESENTATION

Board Representative Darryll Olsen, Ph.D. presented the Board with information regarding the Endangered Species Act (ESA), specifically with Salmon-Steelhead species. Dr. Olsen spoke of the data that has been collected over the years and the litigation that has continued to block the efforts to protect the endangered species in the Columbia River.

- ✓ 13 Salmon-Steelhead Species Listed as Threatened or Endangered Since 1992.
- ✓ Years of Relentless ESA Litigation and Judicial Tyranny.
- ✓ ESA Biological Opinion—Reasonable and Prudent Alternatives (RPAs) for Avoiding Risk of Extinction.
- ✓ Bonneville Power Administration Expenditures—Our Money.
- ✓ More Hydro Project and Water Management Impacts \$\$.

Dr. Olsen asked for the Boards moral support as the GOD SQUAD continues to litigate for ESA. Franklin County Commissioners were all in agreement to support this endeavor.
