In regards to the purpose of the TIP, it is pursuant to Section 36.81.121 RCW, the Board of Franklin County Commissioners is responsible for the preparation and adoption of a comprehensive transportation program for the ensuing six calendar years. The Washington State Department of Transportation (WSDOT) requires submittal of such a program as part of the Statewide Transportation Improvement Program for the allocation of Federal Highway Administration (FHWA) funding. According to WAC 136-15-050(1), the comprehensive transportation improvement program was devised with respect to priorities and needs of the County.

Also, WAC 136-15-050(2), the County Road Engineer's bridge condition report has been provided with the comprehensive transportation improvement program.

The Commissioners discussed various items such as, funding, priorities, unfunded safety enhancements, all weather roads, projects and needs of the county.

Commissioner Didier opened the Public Comment portion of the Public Hearing at 9:29 a.m.

George Dockstader voiced his concerns on wasting county money on Burns and Dent Road, when it will be tore up in a few years when the city takes over. In addition, intersection Road 68 and Clark Road is dangerous and glad to see it on the list of projects.

Steven McFadden, Economic Development Director thanked the Franklin County team in bringing Darigold to Pasco. He thanked Matt Mahoney and Craig Erdman for placing Vineyard Road on the TIP, as Darigold recognized it as an issue with their engineers and the amount of trucks they will be running when the plant is in full service.

John Logue was concerned with focusing on priorities of the county roads and not just the projects that will receive funding.

Commissioner Didier closed the Public Hearing at 9:40 a.m.

Commissioner Didier recessed into Executive Session at 9:47 a.m., for up to 20 minutes to discuss review performance of public employee.


