- James Follansbee attended three of the redistricting meetings. He suggested three lengthwise districts to include, rural, suburb and urban in each district.
 - Citizen concerned with black wastewater from a potato plant.
 - Steve Bauman asked the Commissioners to consider sending a letter stating no support for income tax. Support the efforts in building an additional bridge across the Columbia River.
 - Kevin Heinen asked if the redistricting committee still in effect, and will the East Pasco meeting continue to happen.
 - Administrator Johnson replied that the meeting is temporarily on hold and will take place as soon as the legal gives direction on when to move forward.
 - George Dockstader supports an additional bridge across the Columbia River. He does not support zoom meetings.
 - Curt Didier supported having an East Pasco redistricting meeting.
 - Kevin Shultz voiced his concerns on redistricting and urged those to stand up for equality. Franklin County is 54% Latino and have every opportunity to vote, just like any other citizen.
 - Administrator Johnson explained that he had empathy on those who are concerned about the redistricting process and he is obligated to follow the legal counsel.
 - Commissioner Mullen was disappointed to hear the East Pasco redistricting meeting was canceled. He would like their voices to be heard.
 - Commissioner Didier would also like the East Pasco resident's voices to be heard on the redistricting.
 - Commissioner Peck explained that there is Attorney Client privilege and the Board is legally barred from waiving that privilege individually. This is to avoid the damage to Franklin County in a lawsuit.
 - Steve Bauman attended three of the redistricting meetings and agreed that the East Pasco meeting should continue.
 - Curt Didier supported having an East Pasco redistricting meeting.
 - Clay Whipple supports local representatives to run our community, not those from the West Side.
 - Franklin County Prosecuting Attorney Shawn Sant explained the process of the Redistricting Committee and the lawsuit, which changed the direction of the strategy. This process is not stopping the meetings; it is temporarily postponing them until legal has given us guidance.
 - Sheriff Jim Raymond asked if there was a court order to stop you from talking to the public about redistricting.
 - Commissioner Mullen believed we should have had the East Pasco redistrict meeting.
 - Steve Bauman saw people come together at the meetings and working on a plan for their community. He urged the Commissioners to proceed with an East Pasco meeting.

- ❖ *Proposing an opposing state income tax letter. Commissioner Peck opposed sending such a letter.*


Public Comment
